Old Business	<p>PEMS is not pursuing Critical Care Paramedic Course at this time.</p> <p>2019 Protocols were released last month along with the App (available to EMS, DRs, RNs, etc)</p> <p>2019 Protocol Tests (ALS & BLS) were released a few months ago. OMD must have a request on file.</p> <p>Please remember to use Medical Incident Reports (MIR) for incidents so we can track issues with providers, agencies, policies, or procedures</p> <p>PEMS is again in conversations to assist with a Critical Care Paramedic Course in the region. The following 2020 Protocol Drafts were discussed:</p> <ol style="list-style-type: none"> Adult- Behavioral/Patient Restraint (Ketamine) MAC voted to set dosing to 4 mg/kg IM and remove IV. Rationale was to provide EMS providers with an additional behavioral medication since Toradol, Fentanyl, and Morphine are already available. MAC also asked that the reference to not putting a patient in the prone position be made a bell and moved to the top Adult Pain Management (Ketamine)- MAC voted to increase systolic BP to 110 mmHg for morphine and not to include Ketamine for pain management. MAC did not want to mandate monitoring EtCO2. MAC approved Toradol for AEMT with Medical Control, but not Fentanyl or Morphine. C.
