Riverside Regional Medical Center – B. Lang states that they finished DMV Survey and Comprehensive Stroke Center Survey with good results. She would like to thank the PEMS Region EMS for the support given during these surveys.</li> <li>e. Bon Secours Mary Immaculate Hospital – No report</li> <li>f. Riverside Doctors' Hospital – C. Beck states that blood draw protocols for Williamsburg and James City County are being revised with more information about labeling the blood draw tubes. He plans to send final draft to PEMS.</li> <li>g. Sentara Williamsburg Regional Medical Center – B. Cumbie states that they also have completed the DMV Survey and Stroke Center Survey. Local PEMS EMS agency support has been very helpful and she would also like to thank the PEMS Region EMS for the support given during these surveys.</li> <li>h. Riverside Walter Reed- No report</li> <li>i. Bon Secours Rappahannock General Hospital – S. Parker stated that Gary Samuels is the new RGH and MIH EMS Coordinator.
